Membership Type:

- 6 Months Individual (\$55 Monthly)
- 6 Months Couples (\$100 Monthly) \$50 per member
- 12 Months Individual (\$45 Monthly)
- 12 Months Couples (\$90 Monthly) \$45 per member
- 12 Months Family (\$90 Monthly) + \$20 per each additional person (limit 2)

The Family feature is added to the Couples Massage membership agreement. The Family feature allows primary member to share membership privileges with two other people who are living in the same household. This add-on will increase the cost of monthly membership by \$20 per member. During the membership term, both member and add-on may purchase unlimited massages for themselves, and they may purchase massages for their guest and gift certificates at guest pricing. Member guest and gift certificates are limited to no more than two (2) occurrences for any person in a six (6) month period per primary membership.

1. Clients may choose a membership with commitment periods of (6) months at \$55 a month recurring or (12) months at \$45 recurring with an additional 1 hour free gift certificate.

2. Membership runs from the first day of the month through the last day of each month. Members' dues are paid on first treatment or through automatic withdrawal (recurring billing) with a valid current credit card. I agree to IHCA directly debiting my card on the 15th of each month if member has not come in before the 15th paid and received a treatment. Note: A \$10 fee will be assessed for each credit card denial. It is up to the member to maintain account balances and current credit card information.

3. All memberships will continue as recurring from month to month after commitment ending date at current contract rate. Members may cancel their membership after the first recurring bill date following the commitment ending date with 30-days written notice.

4. Twelve month memberships must be in effect for at least six months, after which, a fee of \$75 will be charged for early cancellation. Three month and six month memberships may not be cancelled. Cancellation request must be in writing or you may use the bottom of this form. Return ALL requests to IHCA. (Fees and/or prices subject to change after commitment ending date.)

5. Membership is valid only for member(s) listed and cannot be transferred or used by anyone other than member.

6. Membership Fees must be current and paid in full to receive any additional discounted purchases or massages.

7. Management has the right to terminate this agreement at any time.

8. **Membership Benefits:** *Each monthly membership fee entitles the member(s) to one one-hour massage treatment per month. A (6) month contract will receive a free 1 hour gift certificate in which you may use yourself or gift to someone else per at the last month of the contract. A (12) month contract will receive 1 free gift certificate the end of each (6) months. Your massage treatment cannot be split but can be lengthened to 90 minutes for an additional \$20.

If you are late it will affect your massage time. If the massage is affected due to the therapist or the center starting late, time will be made up.
